Membership Chair's Report

Happy February! Hope everyone enjoyed the Super Bowl.

This is the February notification that hours need to be entered for the 2019-2020 year before 4/7/2020, as that is the beginning of our new year. There are 62 active members whom do not have their full compliment of hours entered in the database. Of these 6 members have entered no hours, 11 members have 1-5 hours entered, 16 members have 6-10 hours entered, and 25 have entered more than 10 hours so far, and still need a few to finish out the year.

I shall be sending out email reminders to those of you whom still need to complete hours, as per the by-laws. Remember if you have not completed your minimum of 16 hours for the 2019-2020, you shall be assessed

a fine of \$25 per hour not completed. Also remember that a minimum of 8 hours must be completed during one of our major events, and additional fine of \$25 per hour shall be assessed for event hours not completed. For example, if you have 20 hours completed and only 6 of those hours are for events, you must complete 2 more event hours or be assessed \$50 in fines.

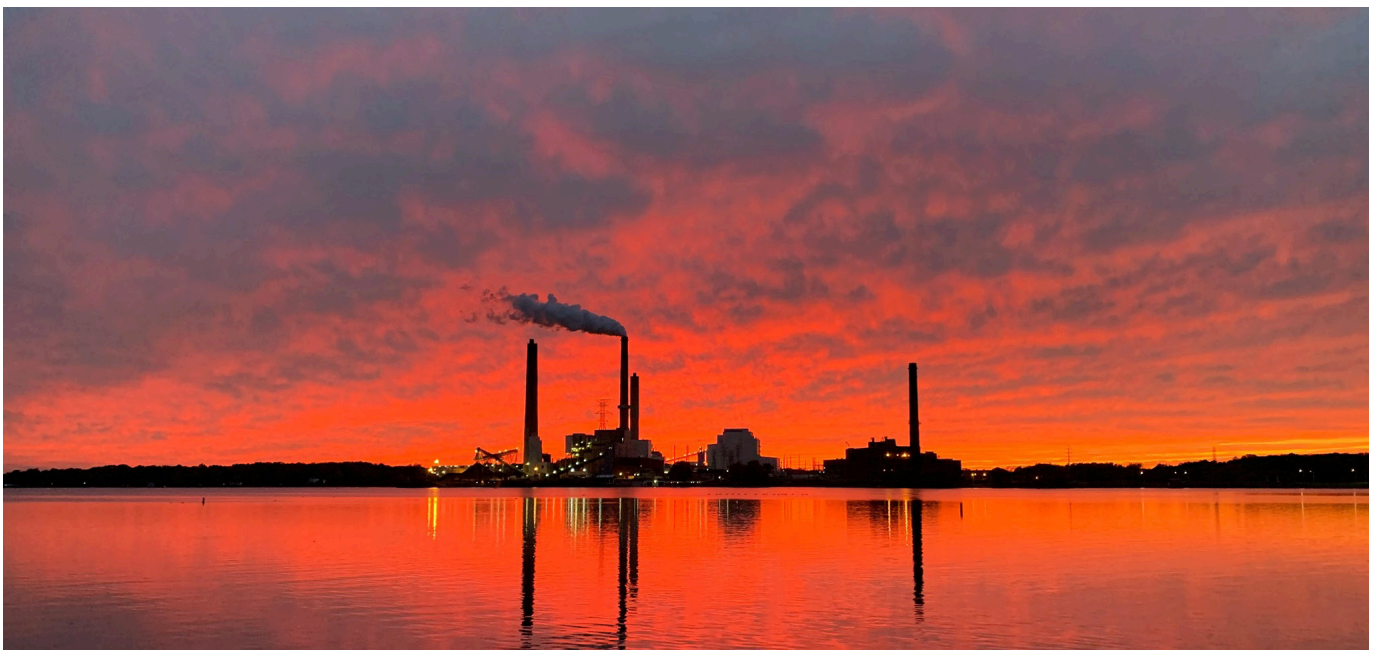
