We are now in the last month of our 2019-2020 year, and that means time to get your dues and fees paid, and to complete and document the remainder of the hours you need to fulfill your commitment to the club.

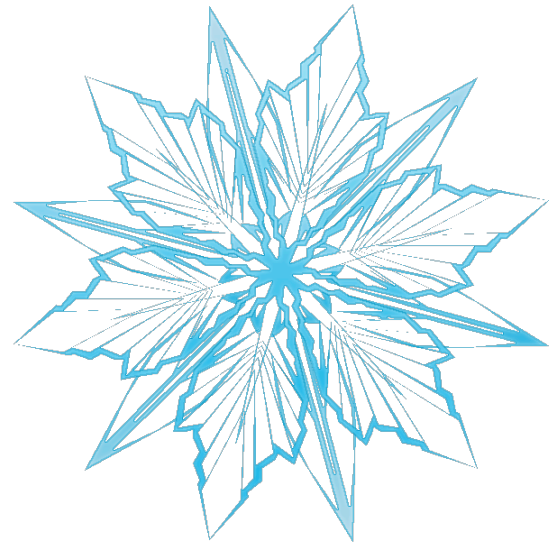
Annual dues are still just \$174, dock fees are \$50, and campsite fees are either \$150 or \$200 based upon when you started as a camper. Please write your check out to the Anchor Boat Club, and note in the memo field that it is for 2020-2021 dues and fees. Place your check or cash in an envelope marked Dues ATTN: Jim C. and drop in the drop safe. Prompt payments are appreciated, they are due prior to April 7, 2020. If there is a reason why you are going to be unable to remit dues prior to April 7th, please do contact me so we can discuss and determine if there is an alternative plan.

All hours must be worked and recorded in the database by April 7th, all members except those who have recently joined are required to complete a minimum of 16 hours, 8 of these are to be during our major events. Remember these are the minimum, not the maximum. Fish Frys started February 28th, and shall continue until April 3rd, these hours shall be counted towards the 2019-2020 year only. We always need plenty more help, so please come on out and lend a hand.

As of the writing of this article there are 55 members left to complete hours, of those 4 have recorded no hours, 11 have between 10-15 to complete, 16 have between 5-10 to complete, and the rest have less than 5 hours to complete. 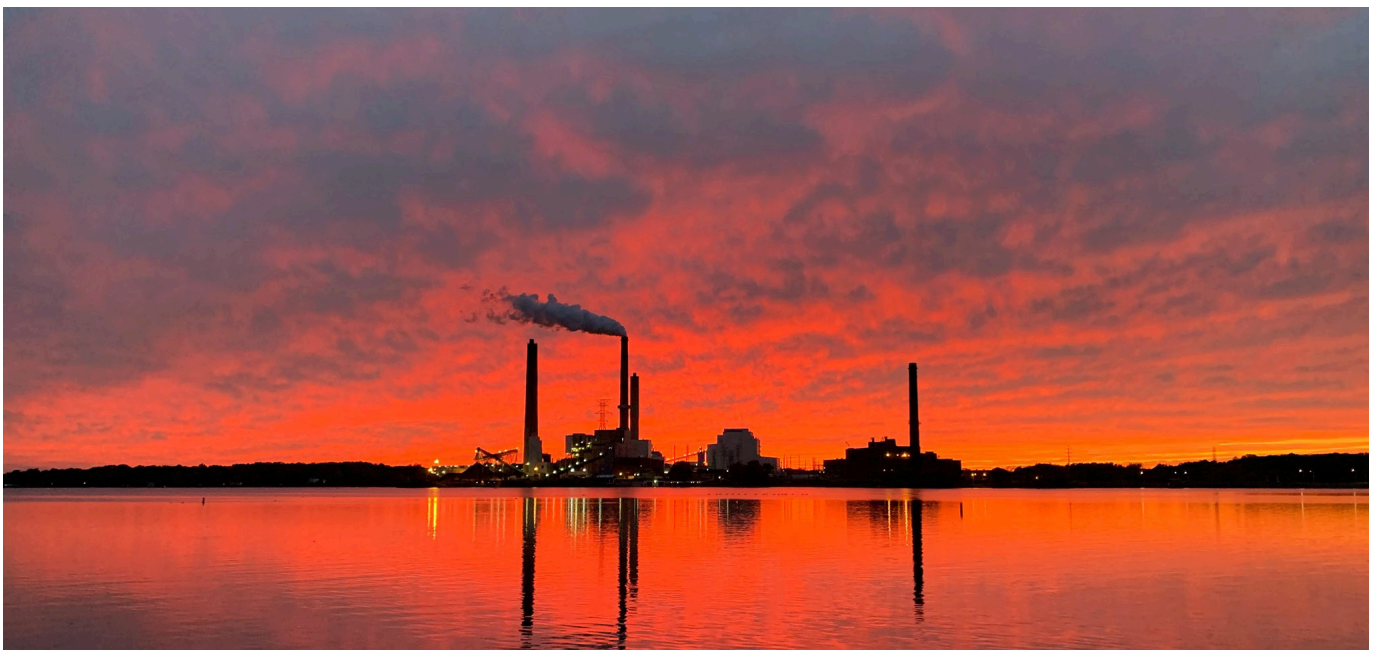
