Hello Members...

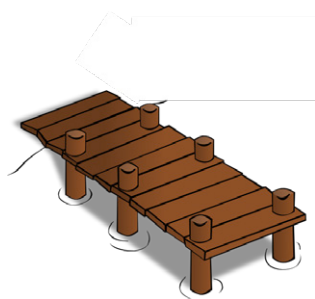

Dock Auction

Proposed by the Board of Trustees and approved during the last Membership meeting, an auction will be held for Mike Hessler's dock on **Tuesday, September 8th at 7:00pm**. Please read the following notes regarding the auction.



- All unopened Bids from previous sealed bid auction will be destroyed.
- The dock will be sold via live auction. Every eligible club member can participate in the bidding process. An eligible member is defined as a member in good standing that is not on probation.
- Opening bid will be \$4000.

On a happier note, I'm glad to say the bar seems to be doing well despite the health concerns of COVID-19!

Just to reiterate due to a change in city rules, **every member must wear a face mask at all times** and must have be seated at the bar or table unless they are going to the restroom or leaving. If a person leaves their table to go visit another table, go to the bar, or use the bathroom, they must wear a face covering. If you notice someone not wearing a mask, we do have a limited supply of masks at the club.



- Whoever wins the auction needs to have a check for \$4000 at the close of the auction (time of sale) and the remainder of the winning bid is due within 30 days.
- If the winner of the auction does not pay the remaining balance within 30 days, the initial \$4000 check will be returned and another live auction will be scheduled. The person who made the previous winning bid will not be allowed to bid in the new auction.
- Date for live auction will be September 8th. **Only the Executive committee, Dock chairperson and eligible members who will be bidding, will be allowed to attend the auction.**
- If you cannot be present to bid on September 8th, you may have another member place bids for you.
