Release and Waiver of Liability, Assumption of Risk, and Parental Consent Agreement

(“Agreement”)

I acknowledge that if the event conditions are deemed to be unsafe, I and/or my minor child will immediately discontinue participation in the event. I am aware that event officials reserve the right to remove any participants from the line-up for any reason. I fully understand the event involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions. Those of others participating in the event, the conditions in which the event takes place, or the negligence of the “RELEASES” named below, and that there may be

other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my negligence as a result of my participation in this event.
